# **Jackson County Offices Reopen to Public with Guidelines and Restrictions**

As of May 18, Jackson County offices have reopened to the public with physical distancing and other important guidelines and restrictions in place. Signs have been posted asking visitors not to enter County buildings or offices if they have been in close contact with a confirmed case of COVID -19 in the past 14 days, or experienced any of the following in the past 48 hours: had a fever or felt feverish, coughing, shortness of breath, sore throat, new loss of taste or smell. County employees are required to participate in a daily screening which involves measuring their temperature and assessing symptoms prior to the start of work. A few Departments plan to screen visitors as well.

- Landfill OPEN Regular Hours: Monday-Saturday from 7a.m.-4:45 p.m.
  - Drivers must remain in vehicle until at worksite area, limited number of vehicles allowed in at once
- Roadside Pick-Up (Rubbish) Services running regular schedules (once a month pick-ups)
